#### Our Year's achievements

#### Impact of COVID-19, one year on...

The implementation of COVIDSAFE measures throughout the year continue to post challenges to the communities holding cultural events and we are grateful that the communities continue to be vigilant as we are not out of pandemic yet as the latest reported indicated.

Since the outbreak of Covid-19 pandemic continues, CMCF executive committee observed the social distance and venue restriction on group gathering, the committee continue to meet online / face to face when required, as well as communicate through social media platform. CMCF is committed to provide daily update on cases, COVID-19 Vaccine's information, and government COVIDSAFE directions. CMCF participated in the community engagement forum and working with ACTH COVID Senior Multicultural Engagement officer to relay community concerns and identified needs and seeking ways to reach out to section of multicultural communities, especially the new and emerging communities to ensure all the government supported / relief programs could be reached and accessible where it was required. CMCF appreciated the work of many communities' charity and volunteers' organisations who work tirelessly to support not only their own communities but sharing generously to whosoever seeking the muchneeded assistance.

CMCF acknowledged the support of ACTCOSS and opportunity for CMCF to voice the concerns of multicultural communities and incorporated our concerns to ACT Government, welcoming some of the key recommendations in the ACT COVID report:

- ACTH further develop the quality and transparency of ACT Government communications on public health directions and other measures in relation of COVID-19:
- Use lessons learnt from the effective partnerships developed between ACT Government and the ACT community sector during the 2021 COVID-19 outbreak to respond to future community needs
- Ensure adequate funding for community services, including mental health support services in response to the needs of Canberra Community.

We acknowledge the ACT Government for providing CMCF with much needed sector funding during 2021 to strengthen our capability to work with community sectors to dissimilate information and opportunity to reach out to our membership on daily basis with updated information. We thank Sam Wong AM on taking on the task of screening through the data by providing a daily summary report through out the last two years. CMCF will continue to advocate and monitor and ensure communities could access to information and support services.

Work in partnership with FECCA and SCoA on community consultation project report on COVID-19 vaccine intake and impact of COVID-19 on community and hosted successful online public community forums targeting multicultural community group during the COVID restriction periods. The forum highlighted the lack of awareness / inability of community in accessing simple COVID related information; there is lack of trust / fear / anxiety with vaccination intake; the lock down / confinement at home and lack of access / contact to relief support during isolation; children education and learning online placed tremendous strain on family relationship. Translated information in different languages are available and accessible to communities and it is important that our members have the information to access the details.

# Harmony Day Pease Bell Ceremony - 20 March 2022

Working closely with Rotary Clubs of Canberra and Canberra Burley Griffin, seven languages were added to the Peace Pole that we unveiled in 2020 as part of the celebration of Harmony Day and marks the 15<sup>th</sup> year Anniversary of the establishment of CMCF. The peace pole carries the wording "May Peace Prevail on Earth "in seven languages. We are working on the development of extra peace pole to be elected on site, carrying more multicultural languages in near future.

#### **CMCF Community Forum**

We managed to host a face-to-face community general meeting with on line facility, inviting Office of Multicultural Affairs and National Multicultural Festival team to inform the community about the latest consultation process relating to the to report on the development of Multicultural Recognition Act (now known as Multiculturalism Bill). CMCF has submitted our response relating to the Bill.

#### Federation Election 2002 meet the candidates Forum – 15 May 2022

CMCF hosted a successful Meet the Candidates forum ensuring ACT Multicultural Voices are heard. Over 22 candidates attended the forum to put their viewpoints on:

# Unlash Resilience of multicultural community Expo – focussing on Mental Health and Wellbeing – August 2022

After much delay due to venue restriction, the community table Expo was organised with 21 organisations participated in the event which was held on 14 August 2022. CMCF was pleased to receive positive feedbacks as the community services shared their information and presented the programs to the participants. We acknowledge the support of Hand Across Canberra to make this possible. The Expo highlighted the golden opportunity for community service providers and program deliverers the opportunity to share information, to promote their services to multicultural communities who otherwise would have little knowledge and understanding the services available and how to access them should there be a need arises. We have set aside some follow up program to continue with our goal to work closely with community sectors and identify the heightened needs of multicultural communities, especially in the areas of disability and mental health matters.

Since the project was launched in December 2021, it has reached out to the target groups and hosted various community round table discussion sessions. Many senior social support groups have been initiated benefited many communities, who are able to enjoy participating actively in community life.

CMCF attended COTA Elderly Abuse Network with membership derived from community services providers, program deliverers, advocated and policy makers, offering avenue to voice of concerns and share community experience in addressing the abuse of older people in our community.

CMCF is pleased and welcome that a new ACT Regional Aged Care Network community forum is established by the Federal Government to improve outcomes of older Australians living in the ACT and would like to encourage our senior community groups to participate in the forum.

CMCF will continue to engage with community services sectors to ensure our older CALD communities able to have access to home help support services. The development of Age-Friendly City plan will ensure that the multicultural community are consulted and included in the development of future action plan.

CMCF Acknowledged and thank ACT Policing for their continuous support and regular liaison with CMCF and for their attendance at CMCF Executive Committee meetings to address issues affecting multicultural community groups and linkage to communities who may need assistance.

#### Community language and multilingual education

### **ACTH Quality Community Engagement Forum**

#### 2022 National Multicultural Festival cancellation

CMCF expressed our disappointment on the cancellation of the 2022 NMF. However, it was acknowledged of the uncertainly to protect public safety during the high of pandemic.

The Minister announced that 2023 Multicultural Festival will go ahead and it will be focussing on community participation. CMCF Chair joined the NMF community Panel Reference Group as one of the 5 appointed members to support the NMF team to promote better community engagement and to ensure the festival returned to the community with the view that the multicultural communities are all together, support each other, sharing with each other's to celebrate multiculturalism. We look forward to the 2023 NMF in earnest.

# **ACT Ministerial Multicultural Advisory Council (ACTMAC)**

CMCF Chair is a member of ACTMAC and is pleased that the Multiculturism Bill was tabled at the ACT Assembly in October 2022 waiting for the debate of the Bill to go through by early March 2022. We are pleased that some of the recommendations were reflected in the Act which include.

- A clear definition of multiculturalism
- Recognise and enhance the freedom to share culture, heritage, language, and social cohesion.
