Our focus has been on:

- Developed better communication strategies by providing target information to our membership and supporting our multicultural community groups to develop an inclusive community.
- Committed and worked collectively to address the priorities and needs of the newly arrived migrants, refugees, and established multicultural communities. Issues such as Health literacy matters, health promotion, and well-being topics, promoting healthy lifestyles, identifying special care needs of multicultural seniors, women's matters, access to services, government public policy issues, and mental health needs.

We have achieved this through our attendance and representation at various community events and forums organised by our members' own community organisations and conducting our own community forums to address issues that have impacts on multicultural communities.

We encouraged the use of community expertise to advise and contribute to submissions. Submissions included the Review of Migration program, National Multicultural Framework review, Human Rights and anti-racism community consultation, Climate change Adaptation Strategy, Voluntary Assisted Dying Bill, and Multiculturalism Bill.

We acknowledge the ACT Government for providing CMCF with much-needed funding from our successful application of various grant programs; strengthening our capability to assist and support our community groups; the ability to disseminate information and the opportunity to reach out to our membership.

KEY EVENTS AND PROGRAMS

CMCF Community Leadership Reception November 2022

With our transition out of COVID restriction and the success of establishing our communication network throughout the pandemic periods, we hosted a successful community leadership reception in November 2022 to end our COVIDSAFE campaign program. The purpose of this reception is to bring together our multicultural community leaders, including the diplomatic corps to share friendship, to interact with each other, to promote and celebrate multiculturalism, and to thank your support to make Canberra a welcoming city and promote harmony.

Sadly, throughout the pandemic time, we have witnessed the increased incidences of racial abuses, experienced by many community groups and individuals. We use the opportunity to focus on our theme of this evening – Racism, It Stops with me campaign.

Voice to Parliament Community Forum – May 2023

As part of addressing the information challenge to recognise First Nations in the Australian constitution, the CMCF hosted a special information event for our members. We acknowledged the support of a one-off donation from the ACT Government to assist with the running of the event.

Community Referendum Forum – August 2023

We organised a community forum and invited the Social Policy Group which was engaged by the Australian Electoral Commission (AEC) to conduct Referendum Community Information Sessions for culturally and linguistically diverse (CALD) communities with the aim of helping all eligible voters participate in the first referendum held in more than 20 years.

FECCA - CMCF partnership involvement - October 2023

CMCF has written to the Federation of Ethnic Community Council of Australia (FECCA) with the support of the ACT Minister for Multicultural Affairs, stating our position as the recognised peak multicultural body representing ACT multicultural community to work with FECCA and represent the ACT.

We are committed to collaborating with FECCA to ensure that ACT's multicultural community is well represented at the national level alongside other key National Peak Advisory bodies. We have been successful in obtaining FECCA project funding to conduct multicultural community consultations to inform the development of the National Anti-Racism Framework on 10 December 2023.

CMCF Community Development Projects

In the coming months, CMCF will be enlisting our community groups to work on a few significant projects: through some of the grants received:

- Advance Care Planning project with the aim to increase the awareness and uptake of Advance Care Planning in the ACT Community.
- Anti-Racism campaign with the aim to establish a multicultural community leaders community conversation forum to promote the Anti-Racism Stop with Me campaign.
- Senior Multicultural Community Leaders Network with the aim of hosting senior community conversation groups and continuing to work with service providers to support our growing population.
- Explore our multicultural community's needs and promote a better understanding of Disability Services accessible to multicultural communities.

ADVOCACY AND REPRESENTATION

As the peak body for multicultural communities in the ACT, CMCF continues to advocate for and represent and be an active voice for the improvement of programs and services for the multicultural community:

CMCF attended regular **Elderly Abuse Network** with membership derived from community services providers, program deliverers, advocates and policymakers, offering avenues to voice concerns and share community experience in addressing the abuse of older people in our community.

CMCF attended the regular **ACT Regional Aged Care Network** community forum has been established by the Federal Government to improve outcomes of older Australians living in the ACT and would like to encourage our senior community groups to participate in the forum.

CMCF attended the regular **CHN Community Advisory Council** as a member of the multicultural community representative to provide advice and recommendations to the Board to ensure that strategies and initiatives are consumer-focused, cost-effective, locally relevant and aligned to improving local healthcare experiences and expectations.

CMCF attended the regular **Community Service Directorate update** online meetings and will continue to engage with various community service sectors to ensure our older CALD communities are able to have access to home help support services. The development of the Age-Friendly City plan will ensure that the multicultural community is consulted and included in the development of future action plans.

CMCF attended as a member of the **ACT Mental Health Multicultural Reference Group** to review the mental health support needs of multicultural communities and develop community engagement strategies and initiatives to enhance the mental health and well-being of multicultural communities in the ACT.

CMCF attended as a member **of ACTH Palliative Care Community Forum**, contributing comments and advice on the development of resource materials and information sensitive to clients' needs from diverse backgrounds.

CMCF continued to liaise with the Multicultural Liaison Officers from the **Citizenship and Multicultural Affairs program**, Department of Home Affairs. We provide feedback of the current state of affairs in the multicultural community and feedback on the skilled migration and migration intake.

CMCF attended the **ACTH Preventive Health** Action Plan 2023-2025 feedback consultation session and provided feedback to ensure actions developed are relevant to the needs of the community.

OUR IMPACT

Community public liability insurance

CMCF continues to offer a long-standing community public liability insurance policy scheme for \$20,000,000 cover, renewable yearly. The scheme has now expanded with cover for contents, volunteers as well as property. The assessment form is comprehensive. Over 65 organizations have joined the scheme and are benefitting from the reduced premium fees.

The scheme is administered by Carol Keil and CMCF acknowledges her dedication to ensuring that new applications and renewals are processed in a timely manner.

CMCF Acknowledged and thanked ACT Policing for their continuous support and regular liaison with CMCF and for their attendance at CMCF Executive Committee meetings to address issues affecting multicultural community groups and linkage to communities who may need assistance.

Community language and multilingual education

CMCF attends the regular Language Network meetings in support of the Community Language Schools, and provides inputs with the development of ACT Language policies. CMCF acknowledges Dr Mandy Scott's tireless contribution and continuous work in pursuing the development of the ACT Language policies and promotion of the Mother Tongue Language celebration events.

ACT Ministerial Multicultural Advisory Council (ACTMACM)

The ACT Multiculturalism Bill was passed and implemented as of 1st September 2023. Eleven members of the ACT Ministerial Advisory Council for Multiculturalism were appointed. The Council will directly advise the Minister for Multicultural Affairs, on the aspirations, needs, and concerns of people from CALD backgrounds who call Canberra home. CMCF will endeavor to work with the Council to ensure that multicultural communities are consulted through various avenues.

Community Development/participation events

CMCF supports our member organisations in their efforts to organise information sessions/workshops and celebrative events and provide guidance and assist new and emerging communities to apply for grants and funding. CMCF will continue to seek funding in support of community organisations and plan to work in partnership with identified community groups and service providers to deliver information and training sessions focusing on community capacity building, health promotion, health literacy and legal Aid services.
